### Manal Hayatleh

Manal Mahd Hayatleh is a Syrian refugee living in Brussels. She holds a degree in Business Administration from Damascus University and a degree in Human Resources Management from the University of Cambridge. Manal worked with UNRWA, the United Nations Works & Relief Agency for Palestine Refugees from 1993 to 2015. She and her Iraqi husband were forced to flee the war in Syria separately. She relocated to Belgium where she continued her active engagement in the humanitarian sector, and was later joined by her husband in Brussels after a lengthy process of family reunification.



### Kristof Vadino

Kristof Vadino is a freelance photographer working for the press and various NGOs. He is published in De Standaard, Le Monde, BBC, De Tijd, Goethe Institute, and others. He works regularly for Médecins du Monde. Kristof made a photo reportage on forced displacement in Europe, "Refugee Odyssey", including chapters on Serbia, Hungary, Greece, France and Belgium. In 2016, he received several awards, including Lensculture Emerging Photographer, Nikon Press Photographer in the 'Stories' category. He finished among the finalists of the Rencontres d'Arles Festival Voies-Off. He follows the news and is involved in long-term projects, such as textile workers in Cambodia or garbage collectors in Haiti and India. Kristof is based in Brussels.



### Chloé Overlau


After graduating from the Solvay Brussels School in 2014, Chloé co-founded 'Association Etudiante d'Aide au Développement', an association providing education for development at the Université libre de Bruxelles. In 2015, she worked as a Housing Coordinator through the 'ULB Students With Refugees' project and was involved with finding host families for migrants and refugees in Brussels. After working on cultural projects for two years, Chloé co-founded the SINGA office in Brussels. SINGA Belgium runs projects to better integrate refugees into Belgian life.



### Deborah Seward

Deborah Seward is Director of the United Nations Regional Information Centre (UNRIC) in Brussels. Prior to arriving in Brussels, she served as Director of the Department of Public Information's Strategic Communications Division at UN Headquarters New York. Before joining the United Nations in 2011, Ms. Seward was an international journalist for nearly 25 years, with postings in Berlin, Bonn, Moscow, New York, Paris, Prague and Warsaw.

**TOGETHER** is a global initiative led by the United Nations that aims to change negative perceptions and attitudes towards refugees and migrants, and to strengthen the social contract between host countries and communities, and refugees and migrants.

In the New York Declaration, all 193 UN Member States unanimously welcomed **TOGETHER** and committed to implementing the campaign. **TOGETHER** will run until the signing of two separate Global Compacts, one on Refugees and one on Migrants, in the second half of 2018.
