With armed conflicts trending upward and proving increasingly complex, the challenges are also mounting for mediators working to resolve them through negotiations. Guidance now available from the United Nations can help them to succeed, providing practical advice for navigating mediation processes effectively. The UN Guidance for Effective Mediation, presented in September 2012 at a high-level event on the sidelines of the 67th United Nations General Assembly, is the first broad UN guidance of this kind available to mediators. It reflects the experience of mediators over more than six decades and was developed in close cooperation with United Nations partners including member states, regional and subregional organizations.

This publication provides practical guidance to Member States for more effective investigation and prosecution of terrorist cases involving the use of the Internet. Terrorist groups and their supporters use the internet to recruit, finance, spread propaganda, train and incite followers to commit acts of terrorism; as well as to gather and disseminate information for terrorist purposes. The use of the Internet for terrorist purposes disregards national borders, amplifying the potential impact on victims.

This new report underlines that, while the trend of ageing societies is a cause for celebration, it also presents huge challenges as it requires completely new approaches to health care, retirement, living arrangements and intergenerational relations. 80 per cent of world's older people will live in developing countries by 2050. The over-60 population will be larger than the under-15 population in 2050.

### **Building a stable and equitable global monetary system (DESA Working Paper No. 118)**

This paper argues that Special Drawing Rights (SDRs) should become a more relevant instrument of international monetary cooperation. This requires transforming them into a pure reserve asset and the IMF into a fully SDR-funded institution. SDRs would then be issued counter-cyclically and treated as deposits of countries in the IMF, which can in turn lend to countries. This approach would correct basic deficiencies of the current global monetary system. Complementary reforms include a substitution account for an orderly and smooth transition from major reserve currencies to SDRs, and the issuance of SDR-denominated bonds as an alternative to other major short-term assets.

The tenth edition of this report shows how vital it is to ensure that all young people have the skills they need to prosper. As the report reveals, however, across the world there is a lost generation of 200 million young people who are leaving school without the skills they need. Many living in urban poverty or in remote rural communities and young women in particular, are unemployed or working for low pay. They need to be given a second chance to achieve their potential.

### **Every woman, every child: from commitments to action: the first report of the independent Expert Review Group (iERG) on Information and Accountability for Women's and Children's Health**

The report concludes that although headline reductions in maternal and child mortality during the past decade have been impressive in some countries, millions of women and children still die every year from preventable causes. Unless those causes are more urgently addressed globally and in countries, Millennium Development Goals (MDGs) 4 and 5 will not be met by most nations by the target year of 2015. What is more, declining rates of donor funding and a failure to target resources to the countries with the greatest need could have devastating consequences for the survival of millions of women and children worldwide.

The international community has advanced in reforming the international aid system. Such reform comes at a time when there is a renewed scepticism about aid effectiveness and when the crisis sheds new doubts about the sustainability of donors' commitments. At the same time, the international reality has changed as a consequence of the growing heterogeneity of the developing world, the new geography of global poverty, the emergence of new powers from the developing world, the presence of new aid players and, finally, the enlargement of the sphere of international public goods. Such changes demand a deeper reform in the development cooperation system.

It has been compiled by UNEP-WCMC in cooperation with IUCN and other partners and with support from UNEP, the Spain-UNEP Partnership for Protected Areas in support of the LifeWeb Initiative, the CBD Secretariat, and the Finnish Ministry of the Environment.

The forest sector in the Russian Federation needs to be modernized using innovations and breakthrough technologies to maximize its potential as a global mitigator of climate change and an important source of timber. The report urges immediate action on modernizing the Russian forest sector, increasing its investment attractiveness, stimulating domestic demand for forest products such as wooden housing and furniture, addressing the illegal logging issues and reforming forest public institutions and legislation.

The future of Somalia and the well-being of its people rest significantly on empowering its large youth population, said the United Nations Development Programme (UNDP) on 28 September 2012 at an event in New York launching the agency's highly-anticipated Somalia Human Development Report 2012. This is the first report of its kind on this war-torn Horn of Africa country in more than a decade. The new report – which is based on surveys conducted in more than 3,000 households in south central Somalia, Puntland and Somaliland - reveals that although the majority of Somali youth believe they have a right to be educated (82%) and a right to decent work (71%), they feel disempowered by multiple structural barriers built into the family, institutions, local government and society at-large.

This report presents new estimates of undernourishment based on a revised and improved methodology. The new estimates show that progress in reducing hunger during the past 20 years has been better than previously believed, and that, given renewed efforts, it may be possible to reach the MDG hunger target at the global level by 2015.

Informal or traditional justice systems resolve up to 80 percent of disputes in some countries and must be integrated into broader development initiatives aimed at guaranteeing human rights and access to justice for all. The report is the most comprehensive UN study on this complex area of justice to date. It draws conclusions based on research in Bangladesh, Ecuador, Malawi, Niger, Papua New Guinea, Uganda, and 12 other developing countries.

If current trends continue, the number of girl child marriages will increase dramatically over the next 10 years, according to a new report released on 11 October 2012 by UNFPA, the United Nations Population Fund, on the inaugural International Day of the Girl Child. The report also finds that, despite laws to prevent its practice, child marriage has remained mostly constant in developing countries over the past decade.

Environmental degradation is a significant factor that reduces the adaptive capacity of societies to deal with disaster risk in many countries around the globe. The balance sheet for the ten years from 2002 to 2011 is alarming: 4,130 disasters, over one million dead and economic losses of at least 1.195 trillion US dollars. This is demonstrated by the 2nd edition of the WorldRiskReport launched in Brussels on 11 October 2012. The report is presented by the United Nations University Institute for Environment and Human Security (UNU - EHS), the Alliance Development Works/Bündnis Entwicklung Hilft and The Nature Conservancy (TNC). The centrepiece of the report, the WorldRiskIndex determines the risk of becoming the victim of a disaster as a result of natural hazards for 173 countries throughout the world. According to the presently available data, the Pacific Island state of Vanuatu has the highest disaster risk, at 36.31 per cent. Malta and Qatar, at 0.61 and 0.10 per cent respectively, face the lowest risk worldwide.
